It is outside of the Village Development Boundary and in an Unsustainable location. In the Planning Statement there are incorrect amenities listed and inaccuracies in distances and bus timetables.

The map on Page2 points to plot inside development boundary.

1.03The Old Forge, a one and half storey dwelling (Fig. 7) that is not listed but might be considered a non-designated heritage asset,......It is!!

Page 5. 1.04 In terms of facilities, the centre of Althorne is 150m to the west (Actually 285m to the junction with Summerhill)where (further to the west) there is access to the railway station that lies to the south off the A(B)1010, about 500m (Actually1.6Km) from the site where the station provides access to Southminster Burnham/ Southend/London Line.

The bus service runs along the road with the bus stop immediately to the east of the pub. The service 31 (or variation) see attached timetable in **Appendix 2**, with stops

at Highfields Rise/Fords corner at Andrews Church to the east Mansion House. (In fact there is one bus a day past the site Mon to Fri at 9-00 heading east. The other nearest bus stop for the 31X is outside what used to be the Post Office at 1.3Km from the site.)

There has been established in recent years two (**Actually one**) vineyards which as well as provide local employment, have associated stores, one of these currently seeking permission to have a visitors centre.
