### 20/114 District Councillors' Report

Comments submitted by District Councillor Mark Bassenger, who was unable to attend in person.

- 1 Cllr Bassenger sends his apologies for non-attendance as he feels it is more appropriate for him to attend a meeting of the Independent Group of Maldon District Councillors.
- 2 In part, this reflects the fact the Cllr. Bryan Harker (conservative) has resigned. This has implications for the balance of power on the council. The Independent Group needs to revise its strategy accordingly.
- 3 As a consequence the Conservative Group now have 12 councillors and the Independent Group has 12 councillors. There are 3 Non Aligned Conservative councillors; 2 Non Aligned councillors and 1 Non Specified councillor (who resigned the Conservative whip), 1 vacancy.
- 4 There will be changes in the composition of the MDC committees, which will be reformed to reflect the changed political composition.
- 5 Re issues relating to the Cllr. Fluker's admitted financial relationship with the former Section 151 officer; it was decided that they were of a personal nature, not a code of conduct violation.
- 6 Issues relating to the Joint Standards Committee (JSC). The referral of Cllr. Bassenger (an Althorne parish councillor at the time) and others (including the current chairman of Althorne pc) was deemed unconstitutional. The JSC has been reformed and Cllr. Bassenger is now a member. Old cases will not be revisited.
- 7 Cllr. John Anderson, Chairman of Southminster pc, who was appointed by the EALC to represent the Maldon parishes, is no longer a member of the JSC.
- 8 It is understood that Cllr. Elaine Bamford has been appointed Leader of the Conservative Group and Cllr. Penny Channer Chairman of the Council.
- 9 In relation to the planning meeting considering an application for exploratory excavations at the Bradwell B nuclear power station site, this was terminated following a dispute over advice given by the Monitoring Officer regarding commercial confidentiality. At a rescheduled meeting the application was rejected virtually unanimously, with only one member in favour.

**BUS NEWS** 

ECC has agreed with bus operators that the times of operation for Essex concessionary bus passes will return to normal hours - 9am to midnight on weekdays and all times on weekends and public holidays from Tuesday, 1st September 2020.

Stephensons advise plans to run the 200/220 service shopper buses when schools resume so service starts Thursday 3<sup>rd</sup> September.

Fords are resuming Shopper Bus Service number 6. First date for Althorne is Friday 11th September

September service alterations have minor revisions to timings on trains on Liverpool – Southend line late evenings on weekdays up to and including 10<sup>th</sup> September, Sunday 13<sup>th</sup> trains scheduled to arrive at Liverpool before 10.00 will terminate at Stratford.
